- ✓ PRINCE2 Foundation
- ✓ Project Management Professional (PMP)®
- ✓ Certified Associate in Project Management (CAPM)®
- ✓ IPMA Level A (Certified Projects Director)
- ✓ IPMA Level B® (Certified Senior Project Manager)
- ✓ IPMA Level C® (Certified Project Manager)
- ✓ IPMA Level D® (Certified Project Management Associate)

Individual IPMA chapters have local interpretations of these certificates, e.g. in the UK the APM is the IPMA chapter. The APM Level D certification is their APM Project Management qualification.

- ✓ It is also relevant to other key staff involved in the design, development and delivery of projects, including:
  - Project board members (e.g. senior responsible owners)
  - Team managers (e.g. product delivery managers)

### Accreditation

The format of the exam is as follows:

- ✓ 150 minute exam duration
- ✓ 38/68 required to pass = 55% pass mark
- ✓ Open book (official PRINCE2 manual only)

### Pre-course

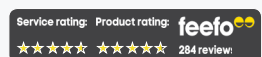
